- adressing problem- requires for international cooperation, humanitarian aid, legal support, health services, education and integration

- beneficiars Ukrainan refugees mostly woman with children

 assistance in the reception and care of Ukrainian refugees and donations of equipment and materials

- 22005 Ukrainan refugees in Croatia at the moment
- registration for temporaray protection
- right to appropriate accommodation



Steps in providing private accommodation services to refugees:




- 1. I have an apartment unit and I want to let it out.
  - 2. I complete the acceptance form, which is on the website of the directorate of civil protection.
    - 3. In my municipality/town, I arrange an inspection of my housing unit with the headquarters of the civil protection.

      I receive a confirmation from the headquarters of the civil protection that my housing unit fulfills the conditions of the offer.
  - 4. After getting the confirmation, submit three documents 1. application form 2. confirmation to headquarters 3. proof of ownership at the address of the directorate of civil protection
- 5. I am waiting for an invitation to sign a contract and accommodate a family from ukraine in my apartment.

- Results integration of refugees in Croatian society, providing them all the help they need and ensuring them safe environment
- Challenges language and communication barriers, mentality and cultural differences, educational system differences, problems with landlords of private accomodation because of tourism purpose and sesonal renting



 DECISION ON FINANCING COSTS FOR HOUSING OF DISPLACED PERSONS FROM UKRAINE IN INDIVIDUAL ACCOMMODATION – City of Šibenik



- 188 families from Ukraine have been accommodated in the City of Šibenik
- mostly mothers with children
- 20 students are enrolled in the school
