#### **Roundtable Discussion**

European Union External Relations with Focus on Eastern Partnership and Russia
Monday 26 September 2011, 14:30-16:00

The Roundtable Discussion will focus on the topic of "European Union External Relations with Focus on the Eastern Partnership and Russia". The Roundtable will serve as a practical and visible starting point for inauguration of the Jean Monnet Centre of Excellence and its focus towards research on Eastern Partnership. The event will be open to public authorities, NGOs and civil society.

#### Background

The geo-political position of Latvia and shared history has an important role in EU external relations, e.g., geographically Latvia has the longest EU external border with Russia. The countries of Western Newly Independent States (NIS) (Moldova, Ukraine, Belarus, and Russia) and the South Caucasus (Armenia, Azerbaijan, Georgia) are of great interest for external political and economic relations for Latvia with potential for further development. The Roundtable Debate will provide a platform for participants from public research, business and government sector to express their ideas on strategic partnerships between businesses and universities and governments. The event will be open to public authorities, NGOs and civil society.

The aim of the roundtable is to exchange ideas about cooperation between enterprises and universities as one of the key priorities for the economic development of the Baltic Sea Region and to help to facilitate business activities and education in the Region.

#### Background

In times of economic hardship it is important that businesses, universities and governments elaborate on research, innovation and development. With no clear end to the currently ongoing economic crisis, there is more need than ever for strategic partnerships all partners involved.

The Roundtable Debate will take place at the University of Latvia on the occasion of the International Conference "European Integration and Baltic Sea Region: Diversity and Perspectives". Prominent speakers from national and international organizations, enterprises, researchers and education experts will be invited to make presentations and participate in the debates.

The Museum of the History of Riga and Navigation Monday 26 September 2011, 19:00 (Palasta Street 4)

The Museum of the History of Riga and Navigation is the oldest in Latvia and the whole of the Baltics, and one of the oldest in Europe. The Museum is situated in Old Riga, in a remarkable architectural monument of the 13th–20th centuries – the ensemble of the Riga Dom.

The history of the Museum dates back to the 18th century. The rich and diverse collections of the Museum originated from an art and natural sciences collection of Nikolaus von Himsel (1729–1764), a Riga doctor. Upon his death, his mother Catherina von Himsel carried out his wish to have his collection handed over to the city of Riga. On 22 February 1773, the Riga Town Council founded a museum, named it after Himsel. During the Second World War as a result of the Baltic German exodus, the evacuation of collections to the German-occupied territories, and the exclusion of the objects that were ideologically unacceptable for the Soviet power, the Museum lost part of its collections. In 1964, it was given its existing name of the Museum of the History of Riga and Navigation, which reflects the new aspects of its activities.
